Vessels up to 10m £21.00 per night

COMMERCIAL OPERATIONS

FISH LANDING DUES

Fish landing dues at 4.3 pence per £1.00 value landed
(Inclusive of berthing charge and water)

Wharfage dues at 2pence per £1.00 value including fish
and shellfish brought onto the harbour by road (VAT
exempt)

Vessels having landed commercially and in commercial
quantities will not incur berthing fees if staying less than
36 hours.

Vessels not landing their catch or vessels staying longer
than 36 hours after landing, casual dues will be paid at
the current rate of £3.66 per m²
